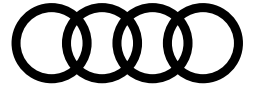


# Audi Certified pre-owned Limited Warranty Transfer Application



## AUDI CERTIFIED PRE-OWNED (CPO) LIMITED WARRANTY TRANSFER APPLICATION

This form and all supporting documentation (see checklist below) must be submitted via mail to:

**REQUIRED:** Copy of documentation evidencing change of ownership and mileage at time of sale\*.

**REQUIRED:** Notarized owner statement (see below) affirming original ownership of the Certified pre-owned vehicle.

*\*Acceptable documentation includes a bill of sale and/or state title application.*

### This vehicle must meet current Audi Certified pre-owned guidelines for transfer eligibility:

- › At time of proposed transfer, the Audi CPO Limited Warranty must be in effect, that is, the vehicle is within age limits.
- › Vehicle must not have been totaled, stolen, exported from the US, imported to the US from another country or have branded title.
- › The Audi CPO Limited Warranty is only eligible to be transferred from private owner to private owner and must be requested by the original purchaser of the CPO vehicle. **Dealership participation is excluded.**
- › Transfer application must be submitted by the original Certified pre-owned owner within 30 days of vehicle sale.

Audi of America reserves the right to refuse transfer in the case of fraud, abuse, failure to meet transfer guidelines, or if the appropriate documentation is not submitted.

**Owner Statement:** "I affirm that I am the original purchaser of the Certified pre-owned vehicle indicated in this form. I further affirm that I have sold the vehicle in a private transaction to the subsequent owner listed below, and authorize the transfer of remaining Certified pre-owned limited warranty coverage to the new owner listed below."
